Your responsibilities:

- Confirmation of the integrity of the master data in all impacted settlement systems and maintenance of master data when factors change (e.g. products, merchants, locations, pricing conditions)
- Monitoring of the daily creation of the DFU files, validation of their content and verification of the successful transfer of the files to the TPCIs (Third Party Card Issuer)
- Checking the accuracy and completeness of the FIBU file, the PDF invoices and their transfer to SAP and the TPCI and dealer invoice
- Investigation of the queries from vendors, merchants, TPCIs and analysis of any potential variances reported by the TPCIs or dealers
